The Series B Preferred Stock has no expiration date.
- These shares are held directly by HQC Acquisition, LLC. The Reporting Person is the President of HQC Acquisition, LLC and it is controlled by Sorenson Capital Partners. The Reporting Person is a Founding member and General Partner of Sorenson Capital Partners and disclaims beneficial ownership of the shares held by HQC Acquisition, LLC except to the extent of his pecuniary interest therein.
- Each share of Series C Preferred Stock is convertible on a one-for-one basis into the number of shares of the Issuer's common stock shown in column 3 at any time at the Reporting Person's election and automatically upon the closing of the Issuer's initial public offering. The Series C Preferred Stock has no expiration date.
- Each share of Series D Preferred Stock is convertible on a one-for-one basis into the number of shares of the Issuer's common stock shown in column 3 at any time at the Reporting Person's election and automatically upon the closing of the Issuer's initial public offering. The Series D Preferred Stock has no expiration date.
